- (e) **RECEIPT OF TENDERS :** If the tenders are received after due date and time even if the delay in receipt was caused in postal transit or any other reasons what so ever, the same shall not be considered and shall be filed unopened.
- (f) **PAYMENT:** The payment shall be made in accordance with the conditions of **Form 'B'**.

1.2 EARNEST MONEY:

The tender shall be accompanied by earnest money amounting to **Rs. 2,000.00** only in the form of CDR / FDR only on any Schedule nationalized Bank endorsed in favour of Executive Engineer, Electricity Test Division (R), Dehradun. Earnest money will be refunded to all except the successful tenderer after the validity of offer/ decision of the tender by the competent authority.

NOTE:

- (a) Please note that no exemption certificate for depositing the earnest money shall be considered.
- (b) No request for adjustment of earnest money from the previous earnest money / securities / pending bills etc shall be considered.

1.3 PRICES:

The rates to be quoted by the tenderer must be firm and exclusive of all applicable taxes.

Any type of condition in rates shall be treated as conditional offer and tender shall be rejected out rightly.

After opening of tender, no offer of any kind which is an amount to validation in prices shall be accepted.

Any action on the part of the tender to revise the price/prices to his own instance after opening of the tender as well as non-fulfilling the offer may result in rejection of the tender. The earnest in such case shall be forfeited and tenderer may be debarred for participation in purchases of the Corporation for a period of one year in first instance.

1.4 WARRANTY OF MATERIAL/SUPPLY:

The warranty period of cubicle box shall be a minimum of one year from the date of installation of cubicle box.

1.5 SECURITY DEPOSITE:

The successful bidder shall have to deposit @ 5% of the total contract value as security amount. The amount is to be deposited before placing of order and should be in form of CDR/FDR in favour of Executive Engineer, Electricity Test Division (Rural), Dehradun. If the successful bidder fails to supply the material within the completion schedule, the security deposit shall be forfeited and the order may be terminated. If the bidder completes the supply within the scheduled period the security deposit shall be adjusted against performance guarantee.

1.6 PERFORMANCE GUARANTY:

In case the supply is completed within completion schedule the security deposit shall be treated as performance guarantee and shall be refunded only after 3 months of completion of warranty period.

In case the supply is not completed within time and the order is not terminated, the bidder shall have to deposited additional 5 % of the contract value as performance guarantee in form of CDR/FDR in favour of Executive Engineer, Electricity Test Division (Rural), Dehradun.

1.7 EXTENSION/PENALTY:

Usually no extension in completion period shall be granted to the supplier, if delayed penalty shall be deducted @ 1/2% per week subject to a maximum of 10% on the work completed after the completion period.

1.8 INSPECTION OF MATERIAL:

The inspection of the material shall be carried out by the undersign (EE, ETD(R), Dehradun) or his authorized representative before supply of material, at Factory / Manufacturing site. If the quality is not found up to the mark, the material will be rejected and decision of the EE shall be final in this regard.

1.9 AWARD OF CONTRACT:

The purchaser reserves the right to award the work to any tenderer not necessarily the lowest and also reserves the right to accept or reject any or all the tenders without assigning any reasons thereof. Purchaser also reserves the right to award the work between two or more tenderer as he may think well.

1.10 OFFER OF PART QUANTITY:

Tenderer who will quote their rates for part quantity their tender will not be entertained and subject to rejection.

Tenderer who have submitted the earnest money in Part, their PART-II shall not be accepted and opened.
