### OFFICE-MEMORANDUM

As per provisions of UERC (Terms and Conditions for Determination of Multi Year Tariff) (Second Amendment) Regulations, 2023 read with Retail Tariff Order dated 30-03-2023 issued by Uttarakhand Electricity Regulatory Commission and in exercise of powers under Section 45 of the Electricity Act, 2003, Uttarakhand Power Corporation Limited (UPCL) hereby notifies that:

1. The Rate Schedule of Fuel and Power Purchase Cost Adjustment (FPPCA), appended hereto, shall apply to all consumers in respect of supply of electricity throughout the area of UPCL. However, no FPPCA shall be charged/refunded on the energy received by the consumers through Open Access.
2. The rate schedule of FPPCA shall be applicable for the period from 01-03-2024 to 31-03-2024. Provided that the consumption of consumers recorded through meter reading taken for the first time on enforcement of this order would be (i) billed at these rates of FPPCA w.e.f. 01-03-2024, in the cases where meter reading is / has to be taken through MRI and, (ii) bifurcated on pro-rata basis for billing at old rates (if any) and these new rates of FPPCA in other cases.
3. FPPCA will not be considered for the purpose of calculation of Low Power Factor Surcharge, Voltage Rebate/Surcharge, Prepaid Metering Rebate and Continuous Supply Surcharge.
